

**Leigh on Mendip Parish Council**  
**Application for the Grant of Exclusive Right of Burial –**  
**Purchase Agreement for the Burial Ground in Leigh on Mendip**

**EXCLUSIVE RIGHTS OF BURIAL CONDITIONS FOR PURCHASERS**

1. The Grant of Exclusive Right of Burial must be purchased at or before the time of the first interment from the Burial Authority. The Exclusive Right of Burial is granted for a period not exceeding 99 years from the date of purchase.
2. The Exclusive Right of Burial Grant must be produced to the Burial Authority when arranging the initial opening or any subsequent re-openings of the associated graves
3. If the Exclusive Right of Burial Grant cannot be produced at the time of the initial or any subsequent interment, appropriate forms of documents that confirm their rights regarding the graveyard plot may be accepted.
4. The owner of the Exclusive Right of Burial in a grave space shall not dispose of such right without the consent of the Burial Authority. The Exclusive Right of Burial cannot be given or passed to another person, it must be transferred following the statutory process. All transfer of such rights shall be prepared by the Burial Authority at an administrative cost of £25.00.
5. Where the Exclusive Right of Burial in a grave spot is not purchased prior to or at the time of burial, the Exclusive Right shall remain with the Burial Authority.
