Application for Erection of a Memorial into the Burial Ground

We apply for permission to erect the memorial described below and agree to comply with the regulations of the Burial Ground in connection with the execution of the work

1. I have read the current edition of the Leigh on Mendip Cemetery Regulations
2. I am the owner as stated in the Exclusive Rights of Burial
3. I accept that the Cemetery Clerk has the power delegated from the Parish Council to permit the erection of a memorial into this Cemetery the monument described below
4. I apply to the Parish Council to grant permission accordingly
5. I do not object to the Monumental Mason's name being incised upon the monument (provided that the requirement's meet the Cemetery Rules)
6. I acknowledge that the monument may be removed 50 years after the death of the person whomit commemorates, or within that period if it ceases to be in good repair.
7. This can be extended providing all cemetery regulations have been met and there will be a charge for the extension
