- 108.2/15 CC had asked Harris & Harris on behalf of the Council to respond stating that the agreement with Mr Brook was an understanding that the plot is to be only used as a cemetery or Garden of Remembrance, the Parish Council had already agreed to pay the costs of his solicitor and planning restrictions on this area of land prevent any development as it is designated as part of the 'protection of spaces and open areas of visual significance'.
- After discussion of the options available CC proposed and it was seconded by GN, agreed unanimously to instruct Harris & Harris to inform Mr Brook's solicitors that the Council would be willing to pay the asking price for the land on the understanding that Mr Brook would pay his own solicitors expenses. The solicitors will also be asked to express the Council's disappointment at the change of mind at such a late stage and make a request to expedite the purchase.
