#### 5 Public Session

No comments from the public.

### 6 County Councillor Reports

Cllr Clarke provided some comments further to a monthly update he had sent]:

- surveys are being carried out on the Boundary Commission review of divisions/councillors in Somerset
- a Somerset business survey is to be carried out
- the public space protection order is being renewed because the previous one has lapsed
- the householder support fund closes at the end of March
- the "man in a van" scheme to provide highways support to parish councils has proved too expensive to be practical for smaller councils
- the last council meeting included a motion in support of local farmers
- some, but not all, councillors involved in reviewing it have provided feedback on the Boundary Commissions proposals for changes to divisions/councillors in Somerset Cllr Ham added a number of points:
- a new NPPF (National Planning Policy Framework) came out before Christmas, with a 41% increase in the government requirement for housebuilding and an associated hardening of grounds for refusing planning permission
- January is a critical month for the resolution of a budget for Somerset Council
- he has communicated with Somerset Council Highways Department on flooding and the damaged grit bin, and awaits a response
- a Shepton Local Community Network meeting is due on 27<sup>th</sup> January, but no paperwork has been issued yet
- farmers have been invited to propose areas of land which could be used in the Biodiversity Net Gain scheme

## 7 Monthly update from Tom Kemp – Parish Tree Officer

TK is waiting for a response from Willmotts on light pollution; Cllr Clarke offered to obtain contact details for Andy Stott as the appropriate person to speak to.

He has planted a 45 metre long beech hedge in the village, comprising 300 trees.

He will draft some words on BNG to reach out to the parish in his role as Biodiversity Adviser to the council. He will forward the draft to the Clerk for circulation to councillors.

Proposed erection of 2 no. 2 bed dwellings attached to existing dwelling.

1 Park Hayes, Leigh On Mendip, Shepton Mallet, Somerset, BA3 5QN

The applicant, Simon James, was present and spoke briefly to his application, answering several questions. He confirmed requirements for parking will be accommodated off road at the property. Comments from parishioners were noted regretting the amount of development which has gone on in Park Hayes and expressing concern at another increase in traffic. After a discussion on design and appearance, highways implications and amenity, Cllr Freeland proposed that on balance the council should recommend approval if the Planning Officer takes into account the Five Year Plan with regard to housing, as well as the Community Plan in which a desire was expressed for more two-bedroom, affordable housing in the parish. Cllr I Kirby seconded and the council voted unanimously to recommend approval. Cllr Freeland to draft comments/arguments and Clerk to apply appropriate comments at the Somerset Council planning portal.

- (b) To agree precept increase and approve (or not) draft budget for 2025-26 (Attachment 5). Cllr Taylor proposed a 5% increase in the precept for 2025-26 to £14,327 and the agreement of the corresponding budget option (with one revision, to increase the budgeted grant to the Recreation Field for grass cutting to £2,000). Cllr Freeland seconded, and council voted unanimously in favour. Clerk to revise and reissue budget, and to submit precept request to Somerset Council.

### 13 Clerk's / Councillors' Report

- (a) The current account update information send to NS&I in relation to the council investment account seems to have resolved any confusion on their part. They have now transferred almost all the funds from the investment account to the council's Unity Trust bank current account, confirmed the investment account balance of £78.01 (including a modest amount of interest) and confirmed the signatories are the clerk along with councillors Taylor and I Kirby. Another form will be submitted to close the account completely.
- (b) The benches for the new cemetery have been ordered from Charltons Timberstore and paid for. Clerk will liaise with supplier, councillors Sweet and E Kirby to have the benches delivered and stored.
- (c) The donation from Whatley Quarry, via James Reed Public Relations, of £600 for the new benches has been received.
- (d) Christmas gifts for the Rangers for the sterling work they do for the parish were organised by C Cudmore; Clerk resolved funding.
- (e) Notification has been received from the Police Community Support Officer that because of poor attendance at the drop-in sessions which have been held they will be discontinued.

  Cllr Ham will also speak to R Massey of Barns Close Quarry regarding actions which could be taken there to mitigate the situation.
