Minutes of meeting held at Memorial Hall on Monday 17th February, 2025

Present: Cllrs Vicki Taylor (Chair), Paula Freeland, Iain Kirby

1 Welcome by the Chairman

The Chair welcomed everyone to the meeting.

2 Apologies for absence

Cllrs E Kirby, S Sweet; Cllr P Ham (Somerset Council)

3 Absent

4 Co-option of Councillor

This item was moved up the agenda.

Vicki Trundle (present) had submitted an application form to fill one of the vacant councillor positions through co-option. Cllr I Kirby proposed that she be co-opted; Cllr Freeland seconded. Ms Trundle was unanimously elected to the council. She signed a Declaration of Acceptance of Office and joined the meeting as a councillor.

Cllr I Kirby left the meeting at this point (18:40).

5 (a) To receive declaration of interest from Councillors on items on the agenda Cllr Trundle pointed out that she is on the Recreation Field Committee.

- **(b) To receive written requests for dispensations for disclosable pecuniary interests** Cllr Vicki Taylor has an approved request for dispensation in relation to Leigh On Mendip Memorial Hall until June 2027.
- (c) To grant any requests for dispensation as appropriate None.

6 Public Session

There were no comments from members of the public.

7 County Councillor Reports

Cllr Clarke spoke to a number of items which appeared on a newsletter provided by him and circulated by the Clerk to councillors.

- The deadline for phase 2 of consultation on the Boundary Commission review for Somerset has been extended to 4th March.
- Somerset Council has agreed to sell a 12 acre heritage site on Frome to Mayday Saxonvale Development Ltd.
- A call for sites has been launched whereby landowners, developers, residents can suggest suitable plots for development.
- A 7.5% increase in council tax has been approved by central government.
- There is a council meeting to approve the budget on 5th March.
- Car park charges are likely to rise from between 10% and 25%, with charges being introduced for overnight parking.

11 Planning Applications – If other planning applications are received between the date of this notice and the date of the meeting, they may be considered.

(a) 2025/0062/HSE

Single storey extension and alter access to create off road parking 1 Spring Cottages, Blackers Lane, Leigh On Mendip, Radstock, Somerset In terms of design, the modification to the wall involved was considered appropriate (James Hiscox was present and spoke about the application). Highways impact is positive since it gets vehicles off the road, and there is no significant impact in terms of amenity. Cllr Freeland proposed recommending approval; Cllr Taylor seconded; council voted unanimously in favour. Clerk to apply appropriate comments at the Somerset Council planning portal.

(b) 2025/0064/FUL

Proposed agricultural access and storage building

Land at E 367364 N 145940 Old Wells Road, Leigh On Mendip, Shepton Mallet, Somerset In terms of design, it was felt that the development proposed would have a negative impact on the character of the landscape. There were strong views on highways impact (including parishioner comments which council noted) - it was felt that the development would significantly increase the risk of accidents at a point which had a history of incidents, including fatalities. Serious concern was expressed on this point. It was not felt that there was any amenity impact since there are no immediate neighbours.

Principally for reasons of highways safety, Cllr Taylor proposed recommending refusal of this application; Cllr Trundle seconded. Council voted unanimously in favour. Clerk to apply comments appropriately.

(c) 2025/0162/FUL

Alteration to Leigh Street vehicular entrance and provision of new timber entrance gate, pedestrian timber gate and associated works

Great House Farm, Hollybush Lane, Leigh On Mendip, Radstock, Somerset Chris Beaver of PlanningSphere, agents for the application, spoke to this application and the others related - 2025/0163/LBC and 2025/0172/FUL.

Comments were made about the appropriateness of the design, specifically that the walls should terminate with strong quoins and a single large irregular coping stone in the manner of the cock and hen detail, or that the prominence of the piers be masked by their finishing with the top of the wall. Council resolved to suggest such an amendment. The development was considered an improvement to highways safety in that it provides better drop off to the site and waiting access. There is no traffic generation. It was felt that appropriate drainage should be secured as part of the development. There is no amenity impact – no neighbours. Cllr Freeland proposed recommending approval, with the inclusion of comments on the

amendment and drainage; Cllr Taylor seconded. Council voted unanimously in favour. Clerk to apply comments appropriately.

(d) 2025/0163/LBC

Alteration to Leigh Street vehicular entrance and provision of new timber entrance gate, pedestrian timber gate and associated works

Great House Farm, Hollybush Lane, Leigh On Mendip, Radstock, Somerset The comments in item 11(c) apply here. Cllr Freeland proposed recommending approval; Cllr Taylor seconded. Clerk to apply appropriate comments.

(e) 2025/0172/FUL

Installation of 452m farm access track

Great House Farm, Hollybush Lane, Leigh On Mendip, Radstock, Somerset

The design was considered an improvement on the existing arrangements. There was thought to be a significant benefit in highways terms because of the improved access which would be set in from the road. There is no amenity impact.

Cllr Freeland proposed recommending approval; Cllr Taylor seconded. Clerk to apply appropriate comments.
