#### 6 County Councillor Reports

Cllr Clarke gave a verbal report, making the following points:

- Somerset Council has made a loss to date of £7M on property sales
- £3M has been spent on a salary and grading analysis of council staff
- Somerset Economic Futures has received an invitation for a cultural collaboration with Ukraine; this has been mentioned previously and the parish council can comment if so minded.
- The work for ground maintenance has been taken in-house from the beginning of June.
- There will be a review of Local Community Networks, their effectiveness and progress made in the time they have been in existence.
- There continues to be an issue with road signs being moved between locations by an unknown party.
- There is a debate being had about the large number of planning enforcement issues and the small number of enforcement officers available to deal with them.

Cllr Ham added several points:

- A bill on planning application assessment is going through parliament which could result in Somerset councillors being unable to challenge applications.
- The council property which was being sold to Saxonvale is now on the open market again.

#### 13 Clerk's / Councillors' Report

- (c) Site visit arranged at Great House Farm in relation to planning applications. An extension to the deadline for comments was obtained from the planning officer to allow consideration of the applications at the next council meeting.
- (d) An update was received from the manager of Radstock Fire Station regarding a review of fire tender access to Park Hayes. He advises that this actually comes under the remit of a different fire service area. He has provided contact details and the Clerk will make contact.
- (e) Chris Cudmore has advised that Somerset Council has been cutting several verges recently including the crossroads at the top of Knap Hill. Chris has cut back some outgrowing hedging on the junction of Old Wells Road and Tadhill Lane. Visibility in these areas is improved but care still required. The Village Rangers will soon be strimming the grass around the stone village signs.
- (f) Details of an urgent road closure in Coleford were published to the usual channels.
- (g) Updated details on the recommendations from the Local Government Boundary Commission were circulated along with means of providing feedback.

#### 14 To Be Discussed / Resolved

- (a) Management of churchyard/cemetery maintenance (Clerk)
  - The Clerk proposed a practical arrangement for the maintenance contract in which the contractor will invoice for cuts done per month in arrears (cost per cut as per original quotation) and agreement will be made when it is appropriate to end cuts for this season (final number of cuts will be less than originally quoted for). Council resolved to approve this proposal.
- (b) Responsibility for churchyard/cemetery (Cllr Freeland) Cllr Freeland provided hard copy documentation of her research into responsibility for St Giles churchyard/cemetery, indicating clearly as described in the minutes of the parish council meeting of 19<sup>th</sup> May that responsibility lies with Somerset Council but Leigh On Mendip Parish Council has agreed to responsibility for ground maintenance.
- (c) Development of biodiversity plan for churchyard/cemetery

  Cllr I Kirby will invite Tom Kemp to talk about this proposal at the next council meeting on 21<sup>st</sup>

  July.
- (d) Somerset Council cultural collaboration with Ukraine
  The parish council will not be commenting on this proposal.
- (e) Appointment of internal auditor for 2025-26.
  - The Clerk proposed that the internal auditor used for the past two years, Eleanor Greene of Do The Numbers Ltd, be reappointed as the internal auditor for 2025-26. Council resolved to reappoint Ms Greene.
- (f) New cemetery (Cllr E Kirby)
  - Cllr E Kirby provided a verbal report:
  - the two benches for the new cemetery will be installed on 17<sup>th</sup> June
  - the plaques for the benches will be installed at the same time
  - drawings for the new gates are being produced
  - investigations continue into improving the path along the side of the cemetery;
  - a note is going out to neighbours in the vicinity of the cemetery to alert them to the work which is imminent
